# Important Information for Current and Future FSOP Grantees

As a reminder, FSOP grantees are expected to work with the Western

Regional Center during the duration of their grant.

A communication plan to interact with your respective Regional Center should be part of your project.

What Your Regional Centers Need from You (also good to consider for your new grant proposals!):

- Evaluation is a required component of leading FSOPs.
- Including an evaluation expert on your team is recommended.
- Evaluation should track participation, outputs, knowledge gain, practice change, and success stories. **Templates are available for recording/reporting this information**.

As per the FY22 RFA, please note: "the Project Director for the Community Outreach and Collaborative Education and Training Project teams will be responsible for attending annual meetings. During the meeting, Project Directors will report on the progress of their projects, share updates on modified training materials or curricula, and report on interim programmatic outcomes." You will be invited to share your work in both the national FSOP Project Directors meetings (in the years when these are scheduled) and your respective Regional Center's Annual Meetings.






## **WRCEFS FSPCA PCHF and PSA Training**

#### 3) Spanish-language Produce Safety Educator's group launch.

# 1) Education and Outreach Coordinator - Commercial Produce Safety Program

The University of Idaho is hiring an Education and Outreach Coordinator for the Commercial Produce Safety Program. This position is a grant funded, 4-year position as a Commercial Produce Safety Program Education, Outreach and Technical Assistance Coordinator. The Coordinator will be responsible for planning, organizing, instructing, and evaluating Produce Safety Rule training programs and technical assistance for produce growers, Extension Educators, and regulatory personnel statewide. This will include Outreach and Education (70%), Program Evaluation and Reporting (20%) and Program Planning and Implementation (10%).

This position is funded by the United States (US) Food and Drug Administration (FDA) through a cooperative agreement with the Idaho State Department of Agriculture (ISDA) to address statewide outreach, education and technical assistance related to the Food Safety Modernization Act (FSMA) Produce Safety Rule.

#### 2) Education/Training Specialist II

The University of Florida Institute of Food and Agricultural Sciences is seeking full-time Education and Training Specialists who will be part of a state-wide team responsible for coordinating, conducting and documenting training activities related to implementation of the FSMA Produce Safety Rule in the State of Florida. This includes organizing and teaching the Produce Safety Alliance (PSA) standardized curriculum as a lead trainer, leading and participating in the on-farm readiness review program (OFRR), conducting general Good Agricultural Practices (GAPs programs), and generally supporting the food safety extension efforts for growers. The candidate will work closely with Food Safety Extension colleagues, County Extension personnel, Florida Department of Agriculture and Consumer Services (FDACS) personnel, and growers and other stakeholders to advance food safety in the Florida produce industry. Successful candidates should be familiar with basic produce growing and packing and have a strong background in food safety/microbiology. This position will require frequent travel throughout the state; a state vehicle is provided.
