
# **Upcoming Webinars and Events**

# Add-on Peer Review Process- Now Open

The Western Regional Center to Enhance Food Safety in collaboration with the Northeast Center to Advance Food Safety (NECAFS) has been working on a peer review process for add-on content that

will be facilitated through the Clearinghouse.

Add-ons are material(s) in addition to standardized curricula that are developed and delivered pre-course, during a course, or post-course as a standalone.

We are excited to announce that the peer review system is **open and accepting submissions**. At this time, only resources in English are being accepted for peer review. ### **Resources and Webinars**


- 1) The California Department of Food and Agriculture in collaboration with the California Farm Bureau Federation and Monterey County Farm Bureau recently hosted a series of webinars about best food safety practices for agricultural neighbors. Topics included reservoirs of *E. coli* O157:H7 and other STEC as well as on and off-farm factors affecting STEC movement and survival. 2) Remote and in-person grower trainings are being offered throughout the Western region. To see a complete listing, please visit the PSA or WRCEFS websites.



# **Job Opportunities**

#### 1) Hydrologist- FDA

There is a vacancy opportunity for a Hydrologist GS-1315-13 in the Office of Food Safety (OFS), Division of Produce Safety (DPS), Fresh Produce Branch (FPS) located in College Park, MD. The **announcement closes on July 20, 2021** or sooner if/when 100 applications are received.

Responsibilities for the position include:

- Performs analyses and evaluation of data samples and documented information gathered during inspections and investigations of fresh produce production.
- Prepares documents embodying policy and program proposals and decisions related to agricultural water issues and how they relate to the safety of fresh produce for human consumption.

 Participates in and provides guidance during the development of training for regulatory specialist and other professionals within FDA on matters related to the use of agricultural water.

#### 2) Northwest Regional Extension Associate- PSA

The Produce Safety Alliance (PSA), based in the Department of Food Science at Cornell University, is a collaborative project with the USDA and the FDA to provide educational outreach assistance to fresh produce growers and packers, including grower cooperatives, to increase their understanding of the critical role they play in public health by implementing food safety practices on the farm and in packinghouses.

As a key member of the PSA team, the Northwest (NW) Regional Extension Associate (REA) will be responsible for planning, organizing, instructing, and evaluating PSA training programs for produce growers, extension educators, and regulatory personnel in their region. Due to extensive national and international collaboration established by the PSA, it is anticipated the NW REA will interact with a diverse population of individuals and groups with specific emphasis in the Northwest including, but not limited to, State Departments of Agriculture personnel, commodity groups, Land-Grant University personnel, and the Western Regional Center to Enhance Food Safety (WRCEFS) collaborators. The NW REA will facilitate and provide leadership for in-person meetings as applicable, conference calls and webinars, and be directly involved in training other individuals to use the developed PSA curriculum; provide continual feedback to PSA leadership through preparation of regional impact reports, training evaluations, and outreach activities; and participate in weekly PSA team calls. Must be willing to travel regionally and nationally a significant amount of time (~50%) pending COVID-19 control, including non-traditional and weekend work hours. This position will be located in the Northwest U.S. with exact location being flexible within the northwest part of the 15 states and

territories of the Western Region.
