Produce Safety Professional Development Workshop

A Second Produce Safety Professional Development workshop will be

held on July 30, 2020. During this half-day, virtual workshop, 25 participants will learn about recent updates to the Produce Safety Rule and how to address tough questions that come up during PSA grower trainings. Other workshop events will include: breakout groups that took deep dives into sticky topics, virtual demonstrations, and a talk on increasing participant engagement.

This workshop is a collaborative effort among the Produce Safety Alliance, WRCEFS, and New Mexico State University.

# **Food Safety Farmer Focus Groups**

This summer, the National Young Farmers Coalition has been holding online food safety focus groups with produce growers from across the country. These focus groups have enlightened both the Coalition staff and fellow young farmers on the challenges and successes surrounding produce safety.

They are continuing to schedule focus groups and are hoping to connect with even more growers. Each hour-long virtual focus group features a farmer co-facilitator who discusses their operation and systems, and up to eight farmers who ask the lead farmer questions and sharing their own experiences. They recognize the expertise that each farmer brings to the conversation, so the farmer co-facilitator and participants will be paid for their time (\$250 and \$50, respectively) and receive a copy of our food safety guidebook: A Small Farmers Practical Guide to Food Safety. All focus groups are being recorded and will be posted on their website for other farmers in their network and beyond to listen and learn from. They are really looking forward to the upcoming sessions, and have listed our scheduled focus groups below, with more being added along the way. # 1) Irrigation Well Demonstration at the Leyendecker Research Center



# **FDA Updates**

- 1) The FDA will be hosting a webinar on Thursday, July 30, 2020 from 2-3pm EST to discuss the 2020 Leafy Greens STEC Action Plan. The action plan, which was released in March, outlines steps the agency plans to take this year to advance the safety of leafy greens. - 2) The FDA has updated its temporary policy regarding Preventive Controls and FSVP food supplier verification onsite audit requirements during COVID-19. To review the updated policy, please click here.
- 3) On July 13th, the FDA annouced the release of the New Era of Smarter Food Safety blueprint. The New Era of Smarter Food Safety represents a new approach to food safety, leveraging technology and other tools to create a safer and more digital, traceable food system. # **Job Opportunities**

1) Research Specialist- The Northeast Center to Advance Food

Safety (NECAFS) seeks a Research Specialist to coordinate and administer several activities of our regional Preventive Controls for Human Foods Workgroup and our national produce safety evaluation efforts. The position reports to NECAFS Assistant Director and works closely with the Director, workgroup members, staff from the Lead Regional Coordination Center, and regional NECAFS partners.

This is an exciting opportunity to help advance and continue to build the growing scope and project activities of NECAFS. Immediate priorities include researching, cataloging, assessing, and sharing through a framework to support small and very small processors the preventive controls for human food resources created by other universities and outreach partners; researching, collecting and posting preventive controls and produce safety material to the Food Safety Resource Clearinghouse; conduct short-term and long-term look back evaluations of attendees at both Preventive Controls for Human Food Qualified Individual and Produce Safety Grower Trainings across the northeast region to document behavior change; create and implement a social media plan for NECAFS; support in drafting NECAFS newsletter communications, and draft portions of NECAFS required annual reports.

We seek candidates with a background in food safety, evaluation and literature-based research. Candidates should be skilled at gathering and reviewing food safety related material for relevancy and accuracy for the intended audience. This position will be part of team where all members work remotely so should be skilled at communicating and coordinating with teleconferencing platforms and working remotely. We seek a good communicator and effective listener, somebody who is able to respond to the needs and ideas of NECAFS network partners in an evolving FSMA landscape. Strong interpersonal skills and an energetic commitment to teamwork are essential.

#### Responsibilities:

- Conduct research and catalog developed materials on Preventive Controls for Human Food and Produce Safety
- Conduct short-term and long-term look back evaluations of producers and processors across the northeast
- Create and implement a social media plan
- Administer the development of success stories
- Support drafting annual reports, and other communication outputs
- Writing, editing, proofreading of educational materials

#### Minimum Qualifications:

- Bachelors of Science in a related field or equivalent
- 3 years of experience in a related position preferred
- Experience in food safety
- Experience with literature-based research in scientific disciplines
- Experience with evaluation
- Experience with adult education approaches
- Strong written and verbal communication skills

2) The FDA has 2 positions that they will soon be advertising within the Produce Safety Network.

These folks will work alongside, and in a similar capacity, to existing Produce Safety Network members based in the Division of Produce Safety.

# The first position will be a CFSAN Produce Safety Network position focused on produce safety efforts in Latin America.

- Will be advertised at the GS14 level, and within the Biologist series (GS-0401);
- Incumbent will direct and coordinate FDA's produce safety training, education, and outreach activities in Latin America.
- Incumbent will support regulatory activities and policy-making activities related to the safety of fresh produce.
- Position will be based within the United States, with travel expected to, and within, Latin America, to support FDA produce safety activities.

The second position will be a CFSAN Produce Safety Network position focused on produce safety efforts in California.

- Will be advertised at the GS14 level, and within the Biologist series (GS-0401).
- Incumbent will support FDA's domestic produce safety training, education, and outreach activities in California, and other states.
- Incumbent will support regulatory activities and policy-making activities related to the safety of fresh produce.
- Position will be based in California, with travel expected domestically and internationally.
